WAIVER AND RELEASE

The undersigned assumes the risk involved in the activity of bicycling, recognizes that bicycling inherently is a hazardous activity, and further recognizes that such bicycling activities may involve, among other hazards, strenuous physical activity and interaction with motor vehicle activity across or along roadways. As a condition of registration and participation in the Suncoast's Rudolph's Reindeer Ride, the undersigned executes this Waiver and Release. Further, the undersigned agrees to wear a helmet suitable for bicycling purposes and operate his/her bicycle(s) in accordance with Florida Laws. Hillsborough, Pasco, and Hernando Counties and Florida's Turnpike Enterprise does not undertake the obligation to inspect such equipment, it reserves the right to reject from participating in bicycling events anyone whose equipment does not appear to be safe for bicycling purposes.
