This shall include any event in which TBF participates or is a cosponsor of, or any of the above events, as well as events specifically hosted by, promoted by, or otherwise involving TBF. The undersigned assumes the risk involved in the activity of bicycling, recognizes that bicycling inherently is a hazardous activity, and further recognizes that such bicycling activities may involve, among other hazards, strenuous physical activity and interaction with motor vehicle activity on roadways. As a condition of membership in TBF, or as a guest participant in any event involving TBF, the undersigned executes this Waiver and Release. Further, the undersigned agrees to wear a helmet suitable for bicycling purposes during any participation in such bicycling events. The undersigned acknowledges that TBF recommends wearing a bicycling helmet meeting ANSI or Snell standards during bicycling activities. The undersigned also acknowledges that TBF reserves the right to refuse any person(s) from participating in any event without such a helmet. Further, while TBF does not undertake the obligation to inspect such helmets, TBF also reserves the right to reject from participating in bicycling events anyone whose helmet does not appear to be safe for bicycling purposes. In the event that the undersigned executes this Waiver and Release for himself/herself and/or for a minor child or children, then such release shall be effective as to each of the minor children listed below in association with the adult signer.
